21 Pursuant to Rule 1015-1(b) of the Bankruptcy Local Rules (the “BLR”) for the
22 United States Bankruptcy Court, Northern District of California, Professional Financial
23 Investors, Inc. (“PFI”), the debtor in the above-captioned bankruptcy case, files this
“Notice of Related Cases.”

The following case is currently pending before the United States Bankruptcy Court,
Northern District of California, San Francisco Division:

In re Professional Investors Security Fund, Inc. (“PISF”), Case No. 20-30579,

assigned to the Honorable Hannah L. Blumenstiel (the “PISF Case”).

1 PFI and PISF (together, the “Companies”) are affiliated entities that until early May
2 2020 were both under the control of Kenneth Casey (“Mr. Casey”). The primary assets of
3 both Companies are certain real properties located in Northern California, some of which
4 the Companies directly own and others of which are owned by certain other affiliates in
5 which the Companies have equity interests. In addition, both Companies are currently the
6 subject of an SEC review for apparent financial malfeasance spanning multiple decades.
7 Michael Hogan was recently appointed the Chief Restructuring Office of both Companies.

8 The PISF Case commenced on July 16, 2020. A status conference in the PISF Case
9 is currently scheduled to be held on September 17, 2020 before Judge Blumenstiel.

10 Given Judge Blumenstiel's involvement with PISF Case, judicial resources will be
11 conserved if the above-captioned action is assigned to Judge Blumenstiel as well.
